The New Berlin Scholarship Fund was founded by a group of New Berlin citizens who were interested in the education of young people of the community beyond high school. Incorporated on May 29, 1963, we operate under the statutes of the State of Wisconsin. The Fund granted its first scholarships in 1964, to nine senior students of the first graduating class of New Berlin High School. Since its inception, we have granted a total of 445 scholarships totalling \$411,635.

Our recipients must be residents of New Berlin. We are proud of the work we have done and will continue to do for our students.
